Hello Union Family,

On Sunday, March 26, 2023, the election for all positions of the UAW Executive Board concluded. We congratulate the newly elected International Executive Board of the United Auto Workers on their historic election victory. This is a momentous occasion for the UAW and its members, as it marks the first time that members have directly voted in a Union election in the organization's history.

The newly elected officials will be leading UAW for a four-year term, and we are confident that they will bring about positive changes that will benefit both members and nonmembers alike. We wish them all the best during their tenure and look forward to seeing what they can achieve as strong Union leaders over this period. The UAW is a powerful Union dedicated to protecting and advancing the rights of its members. This Union has been at the forefront of fighting for better wages, working conditions, and job security for its members. Therefore, it is essential for all workers to be actively involved in their Union in order to take advantage of the collective bargaining power.

At the end of March, Arniece Stephenson and I attended the Special Bargaining Convention in Detroit. UAW representatives from all sectors and from across the country, including Canada and Puerto Rico, attended this Convention to ensure that the members' voices were heard when the UAW sits at the bargaining table. We read resolutions and voted as a united team on what to include in negotiations.

Speaking of elections, the Local 1753 is holding their triennial elections for all positions, including President, Bargaining Committee and Unit Chairs. Please take some time to look at the election posting in this newsletter.

I encourage all members with at least one year seniority in good standing in the Union to consider running for a local position. When running for office, it is important to be knowledgeable, have a plan, and realize that it will be time-consuming. Additionally, it is important to run for the right reasons and to understand that not all of the work will be done on paid time.

By prioritizing the collective needs of your Union, rather than personal interests and goals, you contribute to a better, more effective Union. Furthermore, one must understand that while running for office can be rewarding, it also carries with it a serious responsibility to serve the people who elect you. By being an active participant in our Union, workers can ensure that their voices are heard and their rights are respected.

A great display of using elected office to serve working people is happening right now in our State House and Senate. After the 2022 elections, Michigan Democrats had a clear mission: fulfill their campaign promises. Under the leadership of Governor Whitmer and with support from Sarah Anthony, Angela Witwer, Sam Singh and many other Democrats, state legislators have been successful in repealing Right to Work, passing a prevailing wage bill, and repealing the pension income tax.

The Right to Work law, which had been in place since 2013, allowed

workers to opt-out of paying Union dues even if they worked at a Union shop that had collective bargaining agreements. With these collective bargaining agreements, members get more time off, better health care, higher wages and safer working conditions, to name a few benefits! Unions use members' dues to ensure they can pay workers and cover their healthcare during a strike, host educational events, and perform many other functions necessary for Union business.

The new prevailing wage law establishes the hourly rate of pay and benefits that must be paid to workers on state-funded projects. It is determined by the US Department of Labor and is based on Union-level wages and benefits. The prevailing wage helps ensure that taxpayers get a fair return on their investment in public works projects, while also protecting workers from exploitation by employers.

The repeal of the pension income tax will help retirees keep more of their hard-earned money and put it to use in other areas such as healthcare, education, and retirement investments.

These accomplishments are a testament to the power of Labor-friendly representatives and senators working for the benefit of all Michiganders.

Finally, I would like to recognize the upcoming heritage months and ways to educate ourselves on the cultures, contributions and struggles of our fellow members. April is National Arab American Heritage Month; May is Asian American and Pacific Islander Month and Military Appreciation Month; June is Lesbian, Gay, Bisexual, Transgender, and Queer Pride Month, Caribbean American Heritage Month, Juneteenth (6/19) and Immigrant Heritage Month. The newest addition to our heritage calendar in the U.S., Arab American Heritage month was first recognized by President Joe Biden in 2022. See more about this proclamation at whitehouse.gov. Happy Springtime 2023!

The UAW is an American labor union that represents workers in the United Stated, Puerto Rico and Canada. Founded as part of the Congress of Industrial Organizations (CIO) in the 1930s and grew rapidly from 1936 to the 1950s. The union played a major role in the liberal wing of the Democratic Party under the leadership of Walter Reuther (president of the UAW 1946-1970).

I am sure all you card carrying brothers and sisters know this story by heart! With the recent history breaking legislation, now is the time to share our story with the new brothers and sisters that are soon to join the family. Right-to-Work in Michigan first went into law in 2013.

Michigan repealed Right-to-Work in 2023.

The union private sector should soon begin to see the effects of the repealed Right-to-Work. A lot of the changes you are going to see in your specific work site will depend upon how your company's specific individual private sector contract language has been negotiated and possibly any other stipulations needed to begin/complete the damage to unions that Right-to-Work caused.

No more "free riders" for union negotiated contracts (union representation without paying the dues).

The repeal of Right-to-Work does not affect the public sector, and for the short answer, because State law cannot supersede the Supreme Court ruling.

So, long story short... WE DID IT! Kudos to all who are helping make and keeping the Union strong!

I would encourage everyone to go on a fact-finding mission and boost your base knowledge on the history of the UAW, then share your wisdom and educate those who may need it.... As my mother once said to me at an early age "they can take away your money, your house, your car, but they can never take away your education". Ok. I'll admit, It did take me a while to figure out who "they" were!

When I did some internet research of the popularity of Unions in

America, I found some very interesting information!

Americans enjoy the highest approval rate since about 1965! Historically, support for labor unions was its highest in the 1950!

Union workers make significantly more money than nonunion workers

Union contracts usually have better health care and pensions.

Unions provide a voice and support to the worker, in the workplace.

Unions provide its workers with psychological security as well as the financial security!

Union workers have Weingarten Rights. These rights guarantee an employee the right to Union representation in many circumstances, these rights were established by the Supreme Court in 1975 and must be claimed by the employee. There is no obligation to inform an employee that they are entitled to Union representation.

I would encourage all union brothers and sisters to learn about unions and their history and more importantly, share it with anyone who will listen.

Harold Foster February 15, 1949—February 24, 2023

Harold Foster, a longtime resident of St. Johns and a native of Lansing, died peacefully, surrounded by family, on Friday, February 24, 2023 following complications from heart surgery. He was 74 years old.

Harold was born on February 15, 1949 in Chicamauga, Georgia, the third of five children born to Claud Clark and Margaret Elaine (Rhodes) Foster. The Foster family moved to Lansing when Harold was six, and Harold graduated from J.W. Sexton High School in 1967. On October 14, 1967, Harold married his high school sweetheart, Sherry Smyth. Harold was Sherry's rock, confidant and fiercely loyal partner for over fifty-seven years. They settled in St. Johns in 1982 and together raised their two sons, Jeremy and Jody. He loved his family dearly and was ever proud of his two sons and their accomplishments. To his grandchildren he was "papa" and their biggest fan and advocate.

Harold was instrumental in many committees and organizations, and inspirational to many. A man of humble origins, Harold grew to become the epitome of a public servant, was a talented speaker and proactive listener. He was an advocate for facts, transparency and choices and could positively influence people. Harold never complained - he took action, would work diligently to seek a solution that was in the best interest of everyone and was an example of a positive, influential leader.

Harold began his work at General Motors in 1968, working on the line and quickly advanced to become a Benefit Representative who was highly respected and known by many as the "Union Godfather". He retired in February, 2023. He was the Board President for LAFCU for thirty seven years, nearly four decades, where he was able to make a difference in the community, help others and build relationships. Harold planned annual LAFCU outings to benefit the Greater Lansing Food Bank, and was a proponent of the Lansing State Lugnuts partnership and the LAFCU fireworks display, which thousands of people enjoy annually. He was Past President of the General Motors Credit Council and the editor and business manager of Lansing Labor News. In 1991, Harold organized and co-founded the St. Johns Youth Athletic Association (SJYAA) and coached basketball, football and golf. He earned the Douglas Griffith Award and the Walter Campbell Local Hero Award over the years.

Harold and Sherry wintered in South Wind, Florida, and Harold helped organize the annual GM Snowbirds Banquet. They loved the warm weather and walking the beach. He collected frogs, adored his red jeep, took meticulous care of this three acre lawn, enjoyed a cup of coffee (at any hour of the day) and loved to hum and sing melodies. Harold often let the sport schedule, whether it was MSU basketball, the Lions or WWE, dictate his weekend schedule. In recent years, Harold built a "general store" out-building to house his treasures from auctions and antiquing. Harold was kind, caring, and loving to all, cherished time spent with his family and lived life to the fullest, making an impact and difference in everything he touched.

Harold is survived by his beloved wife of fifty-five years, Sherry Foster; sons, Jeremy (Julie) and Jody (Jennifer); grandchildren, Taylor, Kayl & Zoe (Justin), Bailey, Kaylee, Owen, Kloe, Sophia & Caroline; great-granddaughter, Oakley Mae; his sister, Mary (Jon Briggs) Mabie, as well as extended family members and many dear friends. He was preceded in death by his parents, Claud and Margaret (Rhodes) Foster and brothers, Bob, Denny and Freddie.

Harold spent decades as the editor and business manager here at Lansing Labor News. Many UAW members have met him while he was working at GM and as he was at different union functions taking pictures and talking to people on behalf of the Lansing Labor News. He had a wealth of knowledge on the Lansing areas labor history, and union history in general. Harold would love to talk about current and past issues and the struggles and victories labor was having. He had an insight that only years of experience could bring, and he was happy to share that knowledge with you. Harold also did a lot for the community, holding many positions and helping many organizations. Harold was, simply put, a Union Man—strong on family, labor and friends. And he will be missed. We dedicate these next pages in his honor.




