

Most of what is known as Lansing today is the direct result of the city becoming an industrial powerhouse, which began with the founding of the Olds Motor Vehicle Company in August 1897. Our Building 70 became the Oldsmobile headquarters and remained so until 2004.

We would like to offer these two mementoes from our Lansing facility: a marble brick from the Oldsmobile headquarters and an Alero medallion.

Scholarship Program at Black Lake

Combine the natural beauty of northern Michigan and your desire to be inspired as a union member and what do you get? How about a free trip to the Walter and May Reuther UAW Family Education Center in Onaway, Michigan?

It's a chance to renew yourself, rediscover your family and recommit yourself to labor activism. The 2010 UAW Family Scholarship Program accomplishes this and more.

Since the center opened in 1970, thousands of UAW families have taken part in the program. During the day, parents participate in workshops on issues that affect working families, such as health care, labor rights, trade, and more.

Children ages 3-7 and 8-11 go to day camps where they have a blast with creative arts, music, games, athletics, and swimming. Youngsters ages 12-15 get a small taste of what it's like to be an active, involved citizen with specially designed workshops, plus activities such as golf, swimming, and gym games. Teens ages 16-18 participate in a program to prepare them for the working world.

There's plenty for the parents to do, too. In addition to swimming at the beach or at the indoor pool, there's team sports, nature walks, camping, fishing, and golf at the Black Lake Golf Club next door.

Your union pays for all lodging, food, and program costs. Participants may choose to pay for other things such as group photographs, gift shop items, golf, or activities in nearby communities.

To be eligible, you must be a UAW member in good standing for at least a year and never have attended the scholarship program. This summer's sessions are July 11-16, July 18-23 (also offers a

session in Spanish), and July 25-30.

Before I go, one last thing ... anybody else secretly enjoying the latest Congressional hearings concerning the NHTSA (National Highway Traffic Safety Administration) and a certain car company? Narrowing the earnings gap

It's a fact that there's a huge disparity in what men and women are paid.

It's also a fact that women who become union members earn more and have a strong advocate in working to close this pay gap.

The U.S. Burgay





there was a 20 percent pay gap between what nonunion women earned when compared to their nonunion male counterparts. The pay gap between female union members and male union members was 12 percent.

According to BLS, in 2009 the average union woman earned \$840 per week versus \$628 for her nonunion sister, a union advantage of 34 percent. That's larger than the union advantage among men, which was 22 percent. The union advantage also outweighs the gender disadvantage: Median weekly earnings for women who belong to unions are \$54 higher than the median for nonunion men.

Clearly, it pays for women to be in a union. But there's also a need for more work to be done.

"Unions are strong advocates for women — members and nonmembers alike — in the fight to eliminate sex-based wage discrimination," said Elizabeth Bunn, the UAW's secretary-treasurer. "And, a union contract provides a formal and effective mechanism to address job discrimination, to fight against sexual harassment and to enhance family-friendly workplace policies."

The wage gap isn't because women work in traditionally lower-paying jobs. When comparing usual weekly wages for all men and women who work full-time in the same field, the gap remains:

- Elementary/middle school teacher: \$1,040 for men, \$891 for women (86 % of what men earn).
- Registered nurse: \$1,090 for men, \$1,035 for women (95 %).
- Database administrator: \$1,391 for men, \$1,071 for women (77 %).
- Machinist: \$722 for men, \$501 for women (69 percent).

The UAW seeks to address pay inequity not only through bargaining with employers, but also through supporting legislation such as the Paycheck Fairness Act, which was passed by the House last year and could be considered by the Senate this year. The legislation would deter wage discrimination by strengthening penalties for equal pay violations.

Retiree benefits

Retirees should be aware that your health care is with the UAW Retiree Medical Benefits Trust. The phone number for the Benefits Trust is 1-866-637-7555. They handle only health issues. Questions relating to pension and life insurance need to be directed to the GM Benefits Center at 1-800-489-4646. This leads to an important reminder that if a retiree gets married or remarried, he or she must call the Benefits Trust to activate the health insurance for the new spouse and also call the GM Benefits Center if you wish to elect the survivor's spouse coverage on the pension. This call must be made within 18 months of the marriage or remarriage. The survivor's coverage does not become effective until 12 months after the marriage. The health coverage is effective the date of the marriage.

Retirees turning 65 will be automatically enrolled in Medicare. You should receive the Medicare card in the mail a few months before your birth month. Part A and B is the only coverage necessary. Do not elect Part D or any supplemental program you may be offered. If you are enrolled in Blue Care Network or any other HMO offered you must enroll in the HMO's advantage program. You can obtain enrollment forms by calling the HMO or your benefit rep. Do this at least two to three months in advance of your 65th birthdate.

For retirees turning age 62, the supplement you are receiving in your pension will be extended until age 63, only if your birth date is before September 15, 1949. For those born after that date, the extension must be approved in future contracts. A retiree collecting Social Security Disability before age 62 is not eligible for the extension. Social Security is NOT going bankrupt. Some politicians and opponents of Social Security just want you to believe it is. Saying that Social Security is in danger of financial collapse is a scare tactic and false justification to dismantle this successful government program.

Social Security's trust fund currently takes in more money from worker contributions than it pays out in benefits. Current projections show Social Security able to pay full benefits for almost another three decades. Even in the troubled economy, the total surplus is in the *trillions* of dollars.

Social Security was created by President Franklin D. Roosevelt in 1935 to provide retired workers with guaranteed income, plus increases for inflation added later, for the rest of their lives. Now wellfunded forces in Washington have worked tirelessly to convince this Congress that the debt crisis is a "benefit crisis." And they have made an impact.

A significant number of lawmakers from both sides of the aisle want to reduce long-term debt through an 18-member commission to re-think the government's commitments to Social Security and Medicare.

The threat against Social Security is stronger today than ever. We must appeal to our congressional leadership to steer our lawmakers toward a responsible debt reduction plan that does not harm Social Security and its promised benefits!

Don't let them forget: Today's debt crisis has its roots in President Bush's tax breaks for the wealthy. That – not Social Security – is what jump-started the historic deficits that have continued to mushroom in the wake of federal bailouts and economic recovery attempts.

Please make a call or write a short letter urging the leaders of the 111th Congress to guide our lawmakers toward a debt reduction plan that will not threaten future Social Security benefits or Medi-


