With GM and Chrysler in deep financial trouble and bankruptcy looming, Local 652's GM Shop Chair Jack Graham, 652 Vice President Randy Freeman, Local 602 President Brian Fredline, and I packed our bags and headed to Washington to put a face on the people to be affected by the loss of GM to our country. Lansing Mayor Virg Bernero brought mayors from across the U.S. to also help plead the case for a GM loan to continue operating.

I am thankful to each of them for lobbying on behalf of all of us. As we all know, GM had to file Chapter 11 bankruptcy and reorganize on June 1. We all were waiting on the news about whether

our plants would be operating.

The sacrifices of our active members and retirees were remarkable. Although none of us liked the agreements that were reached, they were necessary for GM and Chrysler to be viable in the future. Our thanks must go to our active and retired members who made the necessary agreements to secure the future of Lansing.

### Unit News

Ryder Unit will be adding 75 drivers and 200 employees in the warehouse as the Lansing Delta Township (LDT) plant gears up for their third shift operation.

Android Industries will be adding 50-60 new employees to coincide with the Delta plant work.

JCIM will also benefit with jobs to help support the Chevy Traverse being built at LDT.

At the Lansing Grand River plant, the target date for launching our new CTS Coupe and CTS Coupe V regular production will be May of 2010. Thanks to our members for all the hard work you do to make sure we have a successful launch!

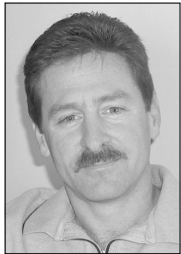

## What changes!

As this New Year begins, I thought it appropriate to show how many challenges we have endured in 2009, and how close we were to disaster. The following are excerpts from my December 15, 2008 "Life on the Line" article. It brings back bad memories!



"This is a defining moment for our industry and for our union. Our future hangs in the balance of the decision makers on Capitol Hill. In spite of all the bad news we have heard lately, there is cause for hope. The White house announced today that they would not allow the domestic auto industry to collapse. The UAW is cautiously optimistic that bridge funding will be given to GM that allows operations to continue outside of bankruptcy until the new administration takes office. The TARP funding is now being considered in addition to the Treasury dept. extending loans to the big three, and the latest numbers suggest that the bridge funding could be anywhere between 10 and 40 billion dollars.

"Strange times make for strange bedfellows. Who would have thought that the Bush Whitehouse would come to the aid of the domestic manufacturers and their workers. I know it may sound cynical but I believe that part of the motivation for "Bush to the rescue" is that he doesn't want his legacy to include the collapse of an entire sector of the American economy. With unemployment spiraling out of control, a credit crisis, and a housing meltdown, layoffs and plant closings, this decision should be a no-brainer. I really don't care what his motivation is, as long as he writes the check. The other cause for hope is that on January 20, 2009 there will be a new President in Washington that understands the need for an American industrial policy that supports the working men and women of this country. We are confident that his economic stimulus plan will begin our turnaround toward stability.

"As we begin this Christmas season, let us give thanks for the blessing we enjoy, and look forward to the New Year with a sense of renewed hope."

Remember when? Here we are one year removed and our plant is adding a third shift and we have a new product. I know this New Year will hold just as many challenges as 2009, but our challenges will come as a result of new people and new product, and not plant closings, layoffs, transfers, and uncertainty.

The UAW and Local 602 have weathered this perfect storm, and there will be more changes to come as we approach the UAW Constitutional Convention in June, 2010. I used to say Merry Christmas and a Happy New Year. I think for 2010, "Happy" is a long shot, so here's wishing everyone a STABLE New Year!

## Local 602 proposed bylaws change

**By-Laws Change Article 14 Section 9**  
Current Language:

### Section 9. Changes or Amendments

These Bylaws may be amended by presenting a motion in writing, setting forth the amendments sought to a membership meeting. The motion shall be read at that meeting and if accepted by a majority of those members present at that membership meeting, the proposed change shall be referred to the Constitution and Bylaws Committee which shall take the proposed amendment under consideration and shall either modify, re-word or present as originally submitted to the succeeding membership meeting, the notice of which must be printed on the plant bulletin boards and published in the union paper, now known as the Lansing Labor News, at least seven days in advance of such meeting, specifying the particular Bylaws amendments that will be considered. If approved by two-thirds of the membership vote thereon at this succeeding meeting, the amendment shall be considered adopted by the membership.

Proposed Language:

### Section 9. Changes or Amendments

These Bylaws may be amended by presenting a motion in writing, setting forth the amendments sought to a membership meeting. The motion shall be read at that meeting and if accepted by a majority of those members present at that membership meeting, the proposed change shall be referred to the Constitution and Bylaws Committee which shall take the proposed amendment under consideration and shall either modify, re-word or present as originally submitted to the succeeding membership meeting, the notice of which must be printed on the plant bulletin boards and published in the UAW Local 602 plant paper now known as "Life on the Line", and posted on the UAW Local 602 website, at least seven days in advance of such meeting, specifying the particular Bylaws amendments that will be considered. If approved by two-thirds of the membership vote thereon at this succeeding meeting, the amendment shall be considered adopted by the membership.

This new language changes the requirement for posting By-Laws changes in the Lansing Labor News to posting in the Life on the Line, in-plant paper, and posting on the Local 602 website. Same seven-day time limit applies for posting.

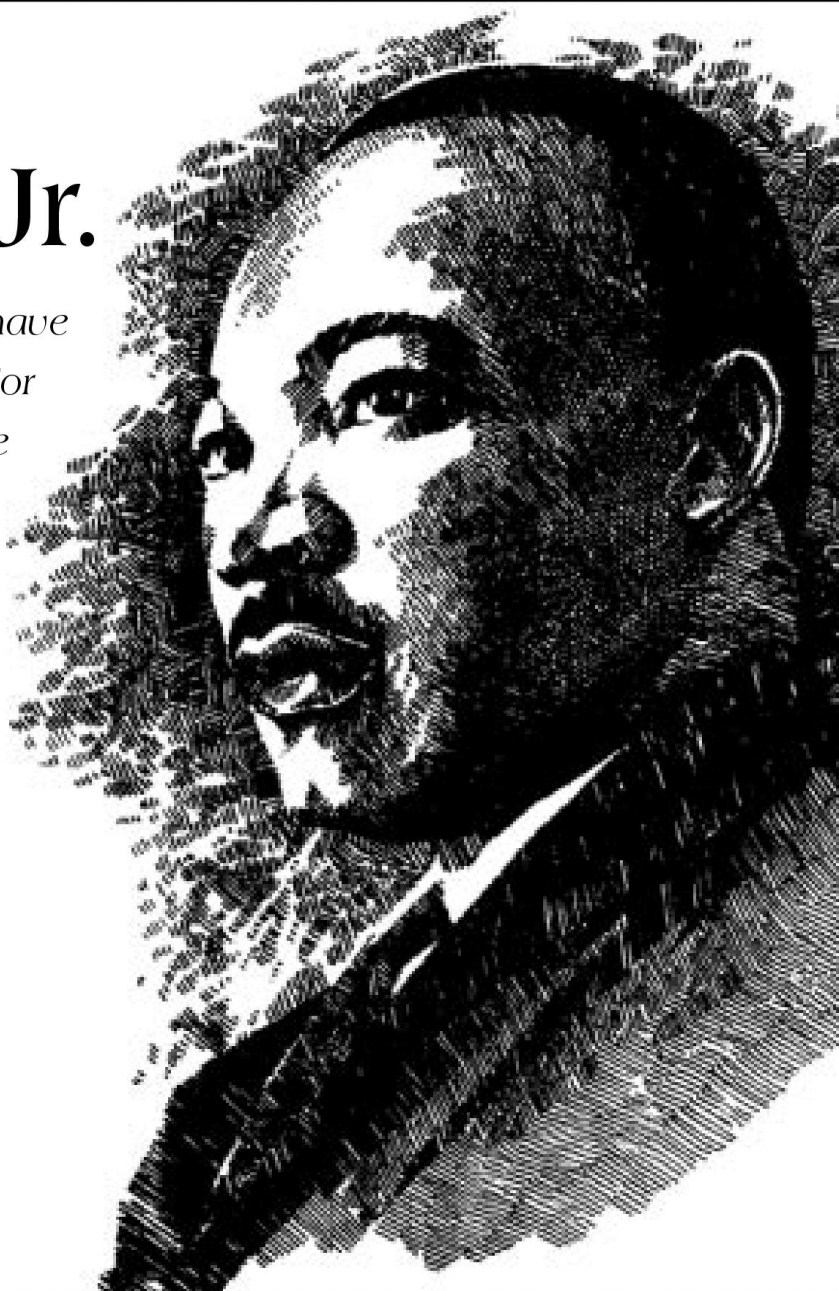
