# Romney just doesn't get it

"We should have let Detroit go bankrupt"!

Mitt Romney doesn't get it; it wasn't a bailout but emergency rescue loans. To qualify for this we as UAW members made deep sacrifices to save the company. We gave up



pay increases, overtime pay, holidays, agreeing to a reduced pay and benefit structure for new hires among other concessions.

It was because these sacrifices the auto industry was able to get those loans, saving more than 1.4 million jobs up and down the supply chain.

The emergency loans worked. GM is once again the world's top carmaker. GM's profits in 2011 were its largest ever and they have repaid their outstanding loans years ahead of schedule.

The Big Three along with their suppliers have added more than 200,000 jobs in the last two-and-a-half years, and 2011 was the strongest year of industry job growth since 1994. Added shifts and new facilities mean jobs for thousands more workers not only here in Michigan, but in many other states across the country.

Unlike a loan, which must be paid back, Romney's not opposed to bailouts. Romney supported the bailout of Wall Street and opposes tough new rules that would stop Wall Street excesses from causing another crisis. Romney has his financial interest in Wall Street, not in you or me.

In listening for the GOP's message of putting people back to work, all we've heard about are more attacks on workers' collective bargaining rights, and this message has been loud and clear.

Mitt Romney promised to take on unions that represent Michigan autoworkers. During his visit to Compatico, an office systems furniture maker in the Grand Rapids suburb of Kentwood, Michigan, Romney boldly stated, "I've taken on union bosses before, and I'm happy to take them on again" and, "I sure won't give in to the UAW."

I am happy the company I work for is doing well but we still have a long way to go before my union brothers and sisters are doing well. I'm concerned that any future gains we hope to make will be taken away at the ballot box as we look at the Republican agenda to dissolve unions and take away our rights as working men and women.

When a Republican candidate can support working people, stand behind my UAW brothers and sisters, and stand up to corporations and big business, I'll vote for them. So far I haven't found one.

# Sprucing up the local

dated things at the Local, so we can start with the most recent development. The Local underwent some major building improvements. Over the years we have experienced issues with

Bids were received and the work was started after Labor Day. It involved digging around the perimeter of the building, putting in new drain tile, installing a water barrier on the outside, and a sump pump. Just wanted to update everyone as to what the old building is going through. Also as a point of reference, the current Local 724 building at one point was the hall for Local 652.

The Local 724 picnic was held in August at a new venue, Valhalla Park in Delhi Township. We had a glorious day to spend with family, co-workers, and friends. The kids were able to play some games, get some goodies and have some wide-open spaces to run around. The Recreation Chair, Todd Collins, again had plenty of prizes for the raffles so the event is always a thing to look forward to. Planning is already underway for the next picnic and volunteers are always needed, so call the Local if you are interested.

The JLL-Drayton Unit recently elected a new Unit chair, Trish Trammell. The Unit has been meeting on a regular basis and is working to make sure the membership has a voice in the workplace.

The Bridgewater Unit started contract talks and is looking to improve the well-being of the membership. They have picked up some new work and will undoubtedly be working hard to incorporate some new ideas into their second contract. Good luck to the committee in their efforts.

In fact, if not for this strategy, many of the current jobs may have been greatly reduced as well. This is an extreme contradiction from President Obama's opposition, Mitt Romney. Candidate Romney was in the mindset to let Detroit go bankrupt. The very fact that this shortsighted attitude could have cost millions of Americans their way of life should cement the idea that he is not the right person to lead our country.

Remember, the UAW screens candidates on the issues that affect our ability to provide for our families through the work we do. The recommendations—and should be looked at objectively. That is why it is critical for us to vote this November. We must review the list of recommended candidates with our families, neighbors, and co-workers to make the choices that will allow us to function as the working class.

Also make sure that the whole ballot is reviewed. There will be three Michigan Supreme Court seats up for election. It is critical that we have judges in the court that will be hearing cases based on their merits, not on who is the most powerful lobbyist. There will several ballot proposals that will also appear. The most important one for union folks is the proposal to protect collective bargaining rights. By insuring that we have a voice in the workplace, we can make sure we are paid fair wages, receive benefits, work safely, and have a recourse in the event of being unjustly treated.

If you have any questions concerning anything that will be on the ballot, please call the local and we will try to help answer your questions. If we can't answer them, then we will look to get them answered.

# What is at stake? The entire middle class

In just a few weeks, we will all have the opportunity to make a difference in

our future and our family's future. We have an enormous number of citizens that could potentially stop the systematic erosion of the middle class family. The 99% versus the 1%;



what is right versus what is wrong; we are all in this together versus you are on your own; what is morally right versus morally wrong. Our philosophy is that we are our brother's and sister's keeper. We help each other in the time of need in whatever way we can. This is how the majority of us grew up—with respectable ethics which govern the way we live our lives.

Today, we are in the biggest economic fight of our lives. While the 99% have

wages that are decreasing, the 1% has wages and company profits that are increasing. While the 1% is quietly funneling money to the Cayman Islands for shelter, the 99% are struggling to keep their houses out of foreclosure, keep their jobs, pay their bills, put food on the table, clothe their children and put gas in the car. How has our society become so twisted and unfair? One reason is because during the election of 2010, only 46% of the people went to the polls and voted. The rest of the people stayed home.

The tragic result is that CEOs and corporations are earning record profits and the wealthy 1% is receiving endless tax breaks. (Recall that billionaire Warren Buffett of Berkshire Hathaway announced that he pays a lower income tax rate than his secretary does!) Some politicians want to undermine and destroy Social Security and make permanent the Bush tax breaks for the wealthy. The 99% continue to struggle by having the Earned Income Tax Credit diminish, our pensions are now taxed, student loan rates are about to skyrocket, and there are some politicians who want to tax your health care benefits as in

## **Election time**

Those of you who regularly read the Lansing Labor News might recall that last year I wrote an article entitled "Why Republicans Hate Unions," every word of which I stand by.

I received a lot of feedback on this article, most of it positive, some of it negative, including a demand that I be removed as Recording Secretary of Local 652.

I have to say I found that particular suggestion undemocratic. I mean removing a duly elected official from office without the consent of those who elected him. But then I realized that maybe the letter writer was Governor Snyder. After all, this is exactly what his emergency manager law does. So if that letter came from you Mr. Snyder, thanks for reading.

Election time is upon us once again and as such this article will be political in nature. That being the case, for those of you who did not appreciate my opinions in that article, or those that have followed, I warn you now that I am once again going to encourage people to vote in a particular way.

On November 6 the citizens of this great country will have the opportunity to exercise their right to vote. While it is a given that many people won't exercise this right, I would beg that everyone reading this do so.

When you do go to vote there are some very important ballot initiatives. Some of these initiatives will help working families and some will not. I would ask that you take the following recommendations under consideration.

First as to Proposal 1, I would strongly urge people to vote against the emergency manager law. Under this law an appointed official can tear up contracts, get rid of employees, and sell property owned by the municipality or school district, without voter approval. That's right, a person who was not elected could sell property paid for by the taxpayers without a vote of any kind. The best part is that your community gets the privilege of paying for this financial dictator. The whole program goes against the very idea of democratic government. So, please, vote NO on Proposal 1.

On the other hand I would encourage you to please vote YES on Proposal 2. This is the proposal that would make collective bargaining a right under the Michigan Constitution. Many of the people reading this are among the approximately 700,000 Michiganders who signed petitions to place this proposal on the ballot in November. Unfortunately, the collection of all those signatures was only the first hurdle that needed to be cleared before the citizens of Michigan were allowed to vote on this proposal. It then had to win at the Michigan Court of Appeals, and finally at the Michigan Supreme Court. Now that those hurdles are behind us, the highest, and most important hurdle remains—which is to pass this proposal on November 6. Please vote, and help clear this hurdle, guaranteeing the right to a voice in the workplace for all of us, as well as for our children and grandchildren.

I would also suggest that you vote

YES on Proposal 3, the Michigan Energy, Michigan Jobs proposal. This initiative requires that 25 percent of Michigan's electricity be generated through the use of wind, solar, biomass, or hydropower processes by 2025. Neighboring states, including Ohio and Minnesota, have already adopted similar initiatives. In all, 30 states have passed laws akin to this proposal. One of the reasons that the UAW has endorsed this proposal was laid out by UAW President Bob King when he stated, "Michigan has the most skilled workers in the world, and Proposal 3 can create thousands of new manufacturing jobs that cannot be outsourced. Proposal 3 will help put our state's manufacturing talent to work, and will help to preserve a healthy environment for Michigan citizens while reining in rising energy costs for businesses." For these and other reasons I would urge you to vote yes on Proposal 3.

The UAW has also come out in favor of Proposal 4 which would establish the Michigan Quality Home Care Council and provide collective bargaining rights for in-home care workers. Among the things this law would do is to provide training for in-home care workers, create a registry of workers who have undergone background checks, and provide financial services to patients to manage the cost of in-home care.

The UAW has also stated a position on Proposal 5. It would require a 2/3 majority vote of the State House and the State Senate, or a statewide vote of the people at a November election, in order for the state to impose new or additional taxes, or to expand the base of taxation or increase the rate of the taxation. This might actually sound pretty good on the surface; the problem is that so long as 1/3 of either the State House or State Senate voted against a proposal it could not pass. So, for example, if every member of the House voted for it as well as 25 of the 38 State Senators it would not become law, because 13 State Senators voted no. I for one believe that this goes against the idea of majority rule. It also bothers me that Washington D.C. Lobbyist Grover Norquist is bankrolling this initiative; our Government and our laws should not be for sale to some Super-PAC. I would urge you to vote NO on

Also, please remember not to leave the voting booth until you have filled out the nonpartisan section of your ballot. I would ask that you vote for Judge Connie Marie Kelley, Judge Shelia Johnson, and Professor Bridget Mary McCormack for Michigan Supreme Court.

All three of these highly accomplished women have been lifelong advocates for working families. These votes are extremely important—what we win at the bargaining table, or even at the ballot box, can be taken away at by our Michigan Supreme Court.

Following is the wording of the ballot proposals as they will appear on the November 6 ballot.

PROPOSAL 12-1

A REFERENDUM ON PUBLIC ACT 4 OF 2011 -

THE EMERGENCY MANAGER

Public Act 4 of 2011 would:

- · Establish criteria to assess the financial condition of local government units, including school districts.
- Authorize Governor to appoint an emergency manager (EM) upon state finding of a financial emergency, and allow the EM to act in place of local government officials.
- Require EM to develop financial and operating plans, which may include modification or termination of contracts, reorganization of government, and determination of expenditures, services, and use of assets until the emergency is resolved.
- · Alternatively, authorize stateappointed review team to enter into a local government approved consent decree.

Should this law be approved?

PROPOSAL 12-2

A PROPOSAL TO AMEND THE STATE CONSTITUTION

REGARDING COLLECTIVE BARGAINING

This proposal would:

- Grant public and private employees the constitutional right to organize and bargain collectively through labor unions.
- · Invalidate existing or future state or local laws that limit the ability to join unions and bargain collectively, and to negotiate and enforce collective bargaining agreements, including employees' financial support of their labor unions. Laws may be enacted to prohibit public employees from striking.
- Override state laws that regulate hours and conditions of employment to the extent that those laws conflict with collective bargaining agreements.
- Define "employer" as a person or entity employing one or more employ-

Should this proposal be approved?

PROPOSAL 12-3

A PROPOSAL TO AMEND THE STATE CONSTITUTION

TO ESTABLISH A STANDARD FOR RENEWABLE ENERGY

This proposal would:

- Require electric utilities to provide at least 25% of their annual retail sales of electricity from renewable energy sources, which are wind, solar, biomass, and hydropower, by 2025.
- Limit to not more than 1% per year electric utility rate increases charged to consumers only to achieve compliance with the renewable energy standard.
- · Allow annual extensions of the deadline to meet the 25% standard in

order to prevent rate increases over the 1% limit.

• Require the legislature to enact additional laws to encourage the use of Michigan made equipment and employment of Michigan residents.

Should this proposal be approved?

PROPOSAL 12-4

A PROPOSAL TO AMEND THE STATE CONSTITUTION

TO ESTABLISH THE MICHI-GAN QUALITY HOME CARE COUNCIL

AND PROVIDE COLLECTIVE BARGAINING FOR IN-HOME CARE WORKERS

This proposal would:

- Allow in-home care workers to bargain collectively with the Michigan Quality Home Care Council (MQHCC). Continue the current exclusive representative of in-home care workers until modified in accordance with labor laws.
- Require MQHCC to provide training for in-home care workers, create a registry of workers who pass background checks, and provide financial services to patients to manage the cost of in-home care
- · Preserve patients' rights to hire inhome care workers who are not referred from the MQHCC registry who are bargaining unit members.
- Authorize the MQHCC to set minimum compensation standards and terms and conditions of employment.

Should this proposal be approved?

PROPOSAL 12-5 A PROPOSAL TO AMEND THE STATE CONSTITUTION

TO LIMIT THE ENACTMENT OF NEW TAXES BY STATE GOV- **ERNMENT** 

This proposal would:

- Require a 2/3 majority vote of the State House and the State Senate, or a statewide vote of the people at a November election, in order for the State of Michigan to impose new or additional taxes on taxpayers or expand the base of taxation or increasing the rate of taxa-
- · This section shall in no way be construed to limit or modify tax limitations otherwise created in this Constitution.

Should this proposal be approved?

PROPOSAL 12-6 A PROPOSAL TO AMEND THE STATE CONSTITUTION

REGARDING CONSTRUCTION OF INTERNATIONAL BRIDGES AND TUNNELS

This proposal would:

- Require the approval of a majority of voters at a statewide election and in each municipality where "new international bridges or tunnels for motor vehicles" are to be located before the State of Michigan may expend state funds or resources for acquiring land, designing, soliciting bids for, constructing, financing, or promoting new international bridges or tunnels.
- · Create a definition of "new international bridges or tunnels for motor vehicles" that means, "any bridge or tunnel which is not open to the public and serving traffic as of January 1, 2012.






